### **Am I eligible for the special Education rate?**

To have the right to buy products at education discounts you must qualify according to the followings guidelines.

- Full-time pupils at a registered public or private-sector secondary education establishment
- Full or part-time students at a registered public or private-sector university or higher education establishment that awards diplomas requiring the equivalent of two (2) years' full-time study
- Teaching or administrative staff employed on a full or part-time basis at a registered teaching establishment

To process and complete your order, you will be asked to provide valid proof that you comply with one of the above

### **What proof must I provide?**

#### **■ Students**

Students must provide a valid student card with their name, photograph and date of issue.

If the student is not able to provide a card with this information, he/she must provide a valid form of identity that has a photograph on it, and some proof of registration at the university/education establishment:

- Official student card without a photograph but with the name and date of issue
- Official and recent statement of marks featuring the name of both the establishment and the student
- Official and recent invoice of registration fees featuring the name of both the establishment and the student
- Any other recent report featuring the name of both the establishment and the student
- Any other official and dated proof of registration

#### **■ Teaching staff**

Members of the teaching staff must provide a valid form of identity with a photograph, and a document proving their position in an education establishment:

- Official and recent pay slip from the establishment in question
- Official and headed letter proving the person's position in the establishment in question

### **How long will my order take to be processed once I have sent the proof?**

Your order will be approved two (2) working days after we have received the necessary proof either by fax on +33 4 38 02 22 00 or by email at [wsstore@winsoft.fr](mailto:wsstore@winsoft.fr)

### **How quickly must I send my proof before my order will be cancelled?**

Your order will be cancelled if we do not receive your proof within four (4) days. If this

happens, you must place a new order via the online store.

**Do you keep the proof for future orders?**

Yes 6 months , but as your status is liable to change every term or semester, you must provide proof each time you place a new order after this period of time.

To be eligible for the special Education rates at WinSoft's online store, you must be a student with a valid student card or a member of the teaching staff in an education establishment, and in both cases you must be buying for your own requirements and personal use and/or for use in teaching or research.
